14/65 Apologies

No apologies were received.

14/66 Variation of Order of Business

No items were identified that required the order of business to be varied.

14/68 Public Speaking

a) Members of the Public and Council to comment on any matter

There were no members of the public present.

Police

No representatives from the police were present.

District & County Council

Cllr Wilkinson reported that some work relating to the drains on Bretby Lane has been undertaken in a neighbouring field during early December 2014. Mr S Toon has attempted to obtain an update from DCC as to when the next phase will be undertaken but to date, he has received no reply. Cllr Chilton reported that a further scheme of works is still awaited from the contractor and this matter will be raised at the next Area Form (on 3rd February 2015). Cllr Smith agreed to raise it formally so that an update will be ready for that meeting.

It was agreed that the wall on Newton Lane has been well constructed but enquiries were made as to why a small section of the wall is still to be completed. Cllr Chilton commented that the delay is for contractual reasons and the road closure is still in force until the end of January 2015.

Cllr Falder enquired about the 2015/16 budget for the County and the District Councils. Cllr Stanton reported that SDDC is unaware how the cuts will be implemented. Cllr Chilton reported that the mobile library service has been cut back to 2 buses; the Highways Dept is depleted and that staff are suffering from stress. She added that the Rural Broadband Scheme is on target. Cllr Meyrick stated that the box on Bretby Lane is in place but the cabling has not yet been extended to the box. Cllr Chilton will pursue this.

Cllr Chilton gave the Clerk a report on the 2011 census which related specifically to Bretby.

She report that a landowner has been served with a notice to repair the defective stile on public footpath 13.

Cllr Smith reported that both DCC and SDDC cannot determine ownership of the proposed area for the siting of the noticeboard on Bretby Lane. Cllr Smith informed that in light of this, the noticeboard could be erected without permission; DCC needs only to be advised of the location (corner of Oldicot Lane and Bretby Lane). The Clerk will advise the owners of 62 Bretby Lane that the noticeboard will be erected.

Cllr Falder enquired why a key will not be provided to the gate on Blindman's Alley and asked how a landowner can obtain access to maintain/cut the hedges and how emergency vehicles can access the area. Cllr Chilton will provide Cllr Falder with contact details for him to make these enquiries direct to DCC.

Cllr Chilton reported that free internal sensor LED bulbs are available to vulnerable people within Derbyshire.

The proposed development of 450+ houses at Hartshorne was discussed. Cllr Stanton explained that where the proposed access is to be located is controversial and that the whole of the A514 is being reviewed.

No application has yet been submitted regarding the 2 rail head applications, but the PR exercises are continuing in relation to both.
