Mr Toone reported on the NHW activities. There have been 11 speedwatch sessions held on Bretby Lane; the results being that there was an average of 10 speeding vehicles per hour. 59 letters have been sent out to speeding motorists and the police have made several visits to those motorists travelling at excessive speed. Mr Toone expressed his hope that there will be some improvements in the speed of vehicles along Bretby Lane.

Cllr Mrs Chilton explained the new ward boundaries. She also attended the Safer Neighbourhood Forum meeting last week and as a result has emailed DCC about concerns raised about the drains in Bretby Lane.

The County Council has bought the case study network system from Nottinghamshire County Council to monitor complaints and the system should be operational in September.

This group sent cameras down the drains on both sides of the lane and DCC now accepts that there is a drain which runs down the drive of 25 Bretby Lane, which goes into the field at the bottom of Winshill, where the drain is broken. An expression of hope for a resolution to the problem of failing drains was given.
