PUBLIC PARTICIPATION

No members of the public were in attendance.

POLICE, DISTRICT AND COUNTY MATTERS

Cllr Stanton reported back that his impression is that funding has been made available for the introduction of faster broadband and that this will take place by 2015.

Hilton, Hatton and parts of Burton are already in the scheme for faster broadband but Repton, which Bretby would fall under, is not yet allocated to any scheme neither has a provisional date been set when such a scheme may be introduced.

Cllr Stanton agreed to remind Cllr Ford about obtain a copy of the Parish map for inclusion on the website.

Cllr Stanton reported to the Parish Council on the matter of parked cars being advertised for private sale on the public highway. He read to the meeting a copy of a letter sent from Mr McArdle (Chief Executive of SDDC) to Mr Hodgson (DCC) regarding this matter. The letter requested that DCC uses its powers to address this problem as the regulatory body whilst SDDC would co-operate by providing instructions to the Neighbourhood Wardens to fully co-operate with DCC. A reply is awaited.

Cllr Falder stated that on a recent journey along the A444, he saw a number of vehicles parked and for sale.

Cllr Stanton added that of any of these vehicles are noted, the details can be provided to James Cunningham Gardiner (Safer Neighbourhood Co-ordinator) on 01283 595943. Cllr Corner suggested that Trading Standards maybe an organisation that could assist. It was agreed that the Clerk would write to Trading Standards to seek their opinion as to whether they would be willing to investigate specific cases.

Cllr Stanton concluded by reporting that the proposal to switch off street lights between midnight and 5am will go to a community consultation between September and November 2012. Whilst specific areas are not known, it is known that some of the lights in Bretby are included in the proposal for the autumn consultation.
