BRETBY PARISH COUNCIL MINUTES OF THE ORDINARY PARISH MEETING HELD MONDAY 23rd MARCH 2015 IN THE WRAGG ROOM, ST WYSTANS, BRETBY

14/83 Apologies

Apologies were received and accepted from Cllr Meyrick (work), Cllr Mrs Newton (health) and Cllr Smith (work).

14/84 Variation of Order of Business

No items were identified that required the order of business to be varied.

14/85 Declaration of Interests:

No declarations were received.

14/86 Public Speaking

a) Members of the Public and Council to comment on any matter

There were no members of the public present.

b) Police, County Council and District Council members to raise any relevant matter

Police

No representatives from the police were present.

Public

Mr Toon informed that at the Repton Forum meeting, 3rd February 2015, all in attendance were advised that work would commence on the Bretby Lane drains in 6-8 weeks, but to date no work has started. An email from Cllr Smith sent prior to the meeting, advised that no works have commenced as DCC has no funds available; the matter that been put back to April 2015 when it will be reviewed and assessed as to its priority against other schemes of works in the county.

All at the meeting expressed frustration at this information as this was the same response received from DCC in 2005 and 2006. It was agreed that not only was it frustrating because the work is not being completed, but also due to the lack of communication on the matter.

Cllr Chilton agreed to make enquiries with the legal dept (DCC) about pushing for the repairs to be carried out.

Regarding the Neighbourhood Watch, there has been very little activity; the only matter being the theft of a trailer from a back garden on Bretby Lane.

District & County Council

Cllr Chilton reported that progress is being made towards Derbyshire obtaining devolved powers, which in the long term will save money.

Elvaston Castle Management Board now has a Chairman and are now seeking Board members.

There will be no changes to the local bus services nor will there be any cuts of wardens at sheltered accommodation.

Gritting of the roads around the county continues to be a contentious issue, with unanswered questions about the audit of the routes and the cost of gritting.

14/89 To receive the Chairman's Announcements

The Chairman reported on his attendance at the Planning Forum (18.02.15). Whilst Derbyshire has the biggest population growth in the last 10 years, there will be no large developments with Bretby, but it is likely that there will be some smaller applications around the Bretby area.

- b) The Clerk reported that the paperwork for a noticeboard on Bretby Lane is still being completed by DCC, after which, notices will need to be erected for a minimum of 28 days. Cllr Smith continues to assist the Parish Council with this matter.

- d) Following the resignation of Mr A Badger, three expressions of interest in the vacancy have been received. No co-option will now take place as the Parish Council elections are to be held on 7th May and no meeting will be held prior to the election date.

This circular has been circulated via email to all Cllrs and includes the Government's Transparency for Local Authorities. This is currently a recommendation of best practice and at the time of writing, it is the Government's intention that the provision of information listed in the report, should be published by Parish Councils with a turnover of less than £25,000 and for it to be mandatory

by March 2015. This Parish Council falls within that bracket. The list of information required to be published on line is generally already provided, the main exception being the inclusion of the accounts, audit reports, bank reconciliations and list of assets and items of expenditure over £100. This list can be quite lengthy, but as all areas of expenditure are currently listed on the agenda and in the minutes; it is proposed that this part of the requirements can be addressed by continuing to provide the information in the minutes and the agenda. This information can be provided and in so doing, the Parish Council will have regard to the Data Protection Act and Freedom of Information Act. DALC has subsequently advised that an audit for the Parish Councils which fall below the £25K threshold will no longer have an audit from 2016/17, but the need to provide the information above, is mandatory and does come into effect from 1st April 2015.
