BRETBY PARISH COUNCIL MINUTES OF THE ORDINARY PARISH MEETING HELD MONDAY 24th JUNE 2019 AT 8:32pm IN THE WRAGG ROOM, ST WYSTANS, BRETBY

19/591 Apologies

Apologies were noted from Cllr Kemp, Cllr Bridges and District Cllr Haines. As a quorum was established, the Chairman commenced the meeting by apologising for the late start. Prior to the Parish Council meeting, there had been an earlier meeting with the Police Crime Commissioner (PCC), which had overrun.

District & County Council

Cllr Chilton informed that she has reported all matters previously raised with her; some works have been actioned but the road sign for the speed humps on Bretby Lane has not been replaced despite Cllr Toone reporting the matter on a number of occasions. The directional sign to the Crematorium, previously located on Ashby Road East, is still missing. Cllr Chilton advised that she will report back to DCC about the meeting this evening with the PCC and she will try to arrange for CREST to undertake a speed survey on Bretby Lane and Knights Lane.

Cllr Chilton noted the concerns raised that the new LED streetlights are dimmer than the previous streetlights.

The Chairman reported that the highway verges had been cut in April and then again today, this schedule of mowing is insufficient to ensure that good visibility for motorists is maintained.

Cllr Churchill report that the Festival of Light will be held this coming weekend at Church Gresley.

It was also noted at the last meeting, that visitors try to access the site of the former castle and are unaware that there is no public access; the foundations are on private land. Consideration will be given to informing members of the public that access is not permitted to the site.

An update on the concerns raised at the last meeting about the Stanhope carpark recycling facilities was deferred to the next meeting.

There are still difficulties with the Old Smithy sewage pipe, which is leaking in parts across the fields. STW has been on site but the problems remain. Cllr Churchill will take this matter to SDDC Flood Team.
