18/442 Apologies

Apologies were noted from Cllr Toone, Cllr Kemp and Cllr Stanton. As a quorum was established, the Chairman commenced the meeting.

18/443 Variation of Order of Business

There was no alteration to the variation of the order of business.

18/444 Declaration of Interests:

Cllrs considered their obligations relating to declaration of interests. The Chair declared a prejudicial interest in planning application 9 2019 0203; he is the tenant. Cllr Meyrick declared a prejudicial interest in planning application 9 2019 0132 as he is the applicant.

There were no members of the public present who made any comments.

b) Police, County Council and District Council members to raise any relevant matter Police

No representatives from the police were present.

District & County Council

Cllr Smith reported that this will be his last meeting as he is standing down at the next election. The development at Sales Lane has definitely been withdrawn and there are no indications that any new applications will be submitted

Planning application 9 2018 1365 is to be considered by the Planning Committee, possibly in early May.

A team of litter pickers/the Clean Team has done a good job of clearing litter along Knights Lane, but sadly within 2 days the litter had returned. For a month the Clean Team will be making targeted efforts to clean the District. Cllr Falder enquired as to who is responsible for the removal of traffic notice signs and made reference to road closure signs which have been left on site, despite the works being completed. Cllr Chilton is to meet officers next week and will mention this problem, together with a flattened road sign on Ashby Road East.

The arrangements regarding the forthcoming Parish Council elections were discussed. Thanks and best wishes were extended to Cllr Smith for his work for the Parish.

Cllr Chilton reported that free driving training is available for older drivers; training provided by DCC.

DCC was one of the lowest funded councils in the country ranking 140 out of 150 councils; Cllrs have lobbied central government and it is anticipated that additional funds will be provided.

The nearest library, which is at Swadlincote is still to be run by DCC and is not earmarked to be run by a community group.

South Derbyshire will be allocated additional police officers, 3 being allocated to rural crime. Previous rural crime officers have regularly changed and it has been difficult for a relationship to become established with farmers; it is hoped that the new officers will be more consistent,
